## **ADDENDUM TO PARTICIPATION AND ARBITRATION AGREEMENT ADDING WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19 ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT**

In consideration of being allowed to participate in any or all of the services and activities, including, but not limited to, those set forth in the Participation and Arbitration Agreement and any related events and activities, the undersigned acknowledges, appreciates, and agrees that: (1) Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, Influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and, (2) Participant for myself, and/or on behalf of my spouse, and minor child(ren)/ward(s) KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and, (3) agree to comply with the stated and customary terms and conditions for participation with respect to protection against infectious diseases and if I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest management employee immediately; and (4) that I, as parent/guardian, with legal responsibility for any minor participant, have read and explained the provisions in this waiver/release to my child/ward including the risks of presence and participation and his/her personal responsibilities for adhering to the rules and regulations for protection against infectious diseases; and, (5) I, for myself and/or on behalf of my spouse, and minor child(ren)/ward(s) as well as on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS CIRCUSTRIX HOLDINGS, LLC, its officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, owners, parent companies, affiliated entities and lessors of premises ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

In consideration of being allowed to participate in any or all of the services and activities, including, but not limited to, trampoline park access, trampoline dodge ball, trampoline basketball, aerial training, fitness classes, trampoline courts, foam pit activities, reduced/altered/theatrical/laser and special effects lighting, snack bar access and any other amusement activities (collectively "ACTIVITIES"), provided by CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company, and its agents, owners, parent company, subsidiaries, affiliated facilities, franchisors, officers, directors, principals, volunteers, participants, clients, customers, invitees, employees, independent contractors, insurers, facility operators, land and/or premises owners, and any and all other persons and entities acting in any capacity on its behalf (collectively "CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company"), I, on behalf of myself and my spouse, hereby agree to forever release, indemnify and discharge CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company on behalf of myself, my spouse, legal partner, my parents, my guardians, heirs, assigns, personal representatives and estate, and all other persons and entities set forth below. I, on behalf of myself and my spouse, hereby acknowledge, agree and represent that immediately upon entering or participating I will inspect and carefully consider CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company's premises and facilities. I, on behalf of myself and my spouse, agree that such entry into CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company's facilities for observation or use of any facilities or equipment or participation in ACTIVITIES constitutes an acknowledgement that such premises and all facilities and equipment thereon have been inspected and carefully considered. I, on behalf of myself, my spouse, and my minor child(ren)/wards, find and accept same as being safe and reasonably suited for the purpose of such observation, use or participation by myself, my spouse, and my minor child(ren)/ward(s). I, on behalf of myself, my spouse, and my minor child(ren)/ward(s) hereby represent that (i) I/we are in good health and in proper physical condition to participate in the Activities in which CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company provides; and (ii) I/we are not, and during ACTIVITIES will not be, under the influence of alcohol or any illicit or prescription drugs which would in any way impair my/our ability to safely participate in ACTIVITIES; (iii) I/we have not been advised against activities by a health professional; and (iv) I/we agree that I/we do not have to participate in any ACTIVITIES I/we do not voluntarily wish to participate in and that I/we will only participate in any ACTIVITIES for which I/we have sufficient skill to avoid injury. I agree that it is my sole responsibility to determine whether I/we are sufficiently fit and healthy enough to participate in ACTIVITIES. I, on behalf of myself, my spouse, and my minor child(ren)/ward(s), agree to be familiar with and to abide by the rules established for the ACTIVITIES, which include without limitation the rules posted in the facility and/or the website. I, on behalf of myself, my spouse, and my minor child(ren)/ward(s), accept sole responsibility for my own conduct and actions, the conduct and actions of my spouse and my minor child(ren)/ward(s), and the condition and adequacy of the equipment.

(1) **ASSUMPTION OF RISK AND RELEASE OF LIABILITY:** I, on behalf of myself, my spouse, and my minor child(ren)/wards, acknowledge and agree that we are voluntarily participating in the ACTIVITIES, which I agree are dangerous and entail both known and unknown inherent risks, including the risk of injury, permanent disability, or even death, deriving from, but not limited to, equipment malfunctions; building malfunctions; lack of supervision, lack of trained trampoline monitors; lack of proper equipment or padding, netting, or other safety measures; slipping; falling; landing; colliding with fixed objects or other people; the negligence or omissions of myself, my spouse, or my child(ren)/ward(s); the negligence or omissions of CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company; or the negligence or omissions of any other person and/or entity on the premises. I hereby voluntarily assume all such risks. I further understand and acknowledge that CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company does not manufacture the trampolines or other equipment in its facilities but purchases and/or

leases the trampolines and equipment and therefore CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company may not be held liable for defective products, including by way of design or manufacture. Despite all known and unknown risks including but not limited to serious bodily injury, permanent disability, paralysis and loss of life that may be sustained while on or about CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company's facility, I, on behalf of myself and my spouse, hereby expressly, unconditionally and voluntarily remise, release, waive, relinquish, acquit, satisfy and forever discharge and agree and covenant not to sue CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company; its suppliers, designers, installers, manufacturers; or the suppliers, designers, installers, or manufacturers of any trampoline equipment, foam pit material, or such other material and equipment in CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company's facility (all hereinafter referred to as "EQUIPMENT SUPPLIERS"). I, on behalf of myself and my spouse, agree to hold said parties harmless of and from any and all manner of actions or omission(s), causes of action, suits, sums of money, controversies, damages, judgments, executions, claims and demands whatsoever, in law or in equity, including, but not limited to, any and all claims which allege negligent acts and/or omissions committed by CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company or any EQUIPMENT SUPPLIERS. I understand and agree that this Assumption of Risk and Release of Liability prohibits me or my spouse from filing a lawsuit against CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company or any EQUIPMENT SUPPLIERS even if myself or my spouse suffers damage, loss, personal injury, emotional injury, or death and even if the damage, loss, personal injury, or death was caused by any act or omission of CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company or any EQUIPMENT SUPPLIERS.

**(2) ASSUMPTION OF RISK AND INDEMNIFICATION:** I understand that the known and unknown risks may be caused in whole or in part by the actions or inactions myself, my spouse, my child(ren)/wards, others participating in activities, CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company, or any EQUIPMENT SUPPLIERS. In consideration of being allowed, along with my spouse and my minor child(ren)/ward(s) to enter onto and into CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company's facilities for observation or use of any facilities or equipment or participation in ACTIVITIES, I hereby assume all risk of damage, loss, personal injury, or death to myself and my spouse, while in or about the premises, while participating in or as a result of participating in any of the ACTIVITIES in or about the premises, or while using any items purchased in or about the premises, including any such loss due to the sole or partial negligence of CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and all EQUIPMENT SUPPLIERS. I agree to indemnify and hold harmless CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and all EQUIPMENT SUPPLIERS from and against any and all losses, liabilities, claims, obligations, costs, damages and/or expenses whatsoever paid, incurred and/or suffered by CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and all EQUIPMENT SUPPLIERS as a result of any claims asserted by myself or my spouse against CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and all EQUIPMENT SUPPLIERS, including, but not limited to, any and all attorneys' fees, costs, damages and/or judgments CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and all EQUIPMENT SUPPLIERS incurs in the event of such loss, whether or not such losses, liabilities, claims, obligations, costs, damages and/or expenses are caused by the negligence or fault of CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company or any EQUIPMENT SUPPLIERS. I, on behalf of myself and my spouse, further agree to indemnify and hold harmless CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company for any injury, damage, or harm myself or my spouse cause to CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company or its facility or to any other persons or entities acting in any capacity on behalf of CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company, whether or not such injury, damage and/or harm is also caused by the negligence or fault of CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company or any EQUIPMENT SUPPLIERS.

**(3) LIABILITY FOR PROPERTY:** I, on behalf of myself and my spouse, agree that CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company is not liable to us or our guests for any personal property that is damaged, lost, or stolen while on or about the CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company premises including, but not limited to, a vehicle or its content or any property in a locker or otherwise, whether or not CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company was negligent.

**(4) ATTORNEYS' FEES:** To the extent permitted by law, I promise to indemnify and pay CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company for any attorneys' fees and/or costs incurred to enforce the Mediation and/or Non-Binding Arbitration portions of this agreement, including all costs associated with any collection efforts.

**(5) PHOTO RELEASE:** By entering CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and participating in the ACTIVITIES, I, on behalf of myself, my spouse, and my child(ren)/ward(s) hereby grant CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company the irrevocable right and permission to photograph and record me, my spouse or my child(ren)/ward(s) in connection with CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and to use the photograph or recording for all purposes, including advertising and promotional purposes, in any manner and all media now or hereafter known, in perpetuity throughout the world, without restriction as to alteration. I, on behalf of myself, my spouse, and my child(ren)/ward(s), waive any right to inspect or approve the use of the photograph or recording, and acknowledge and agree that the rights granted by this release are without compensation of any kind.

**(6) TERMS OF AGREEMENT:** I understand that this agreement extends forever into the future and will have full force and legal effect each and every time I, my spouse, or my child(ren)/ward(s) visit CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company, whether at the current location or any other CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company location or facility, including, or any of its subsidiary or affiliates' locations or facilities. I, on behalf of myself, my spouse, and my child(ren)/wards, further expressly agree that this agreement is intended to be as broad and inclusive as is permitted by the laws of this state and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in

full legal force and effect.

(7) **MEDIATION:** If a dispute arises out of or relates to (1) this Agreement, (2) CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company's premises and facilities, (3) the use of the premises and facilities, (4) any incident that occurs while on the premises and facilities, (5) any items purchased in or about the premises or facilities, or (6) the installation, design, construction, and condition of the facility by CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and/or EQUIPMENT SUPPLIERS, involving a single claimant, or claimants who are related or asserting claims arising from a single incident and if the dispute cannot be settled through direct negotiations, and unless the parties agree on a different mediation process, the parties agree first to try in good faith to settle the dispute by mediation administered by the American Arbitration Association (the "AAA") under its Commercial Mediation Procedures available at <http://www.adr.org> before resorting to non-binding arbitration.

(8) **NON-BINDING ARBITRATION AND VENUE:** If following mediation, there are any unresolved claims arising out of or relating to (1) this Agreement, (2) CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company's premises and facilities, (3) the use of the premises and facilities, (4) any incident that occurs while on the premises and facilities, (5) any items purchased in or about the premises or facilities, or (6) the installation, design, construction, and condition of the facility by CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and/or EQUIPMENT SUPPLIERS, involving a single claimant, or claimants who are related or asserting claims arising from a single incident and unless the parties agree on a different non-binding arbitration process, such claim or claims shall be submitted to non-binding arbitration administered by the AAA in accordance with its Non-Binding Consumer Arbitration Rules, except that Rule R-2 (e) is amended to allow an answer to be filed within thirty (30) calendar days. The arbitration shall be governed by the laws of the State in which the CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company facility is located. In-person hearings will take place pursuant to the Non-Binding Consumer Arbitration Rules in the county/parish and state in which CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company is located. Except as may be required by law, neither a party nor an arbitrator may disclose the existence, content, or results of any non-binding arbitration hereunder without the prior written consent of both parties. The parties agree to non-binding arbitration of any and all claims, disputes and grievances, not otherwise excepted herein, arising out of or relating to (1) this Agreement, (2) CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company's premises and facilities, (3) the use of the premises and facilities, (4) any incident that occurs while on the premises and facilities, (5) any items purchased in or about the premises or facilities, or (6) the installation, design, construction, and condition of the facility by CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and/or EQUIPMENT SUPPLIERS. A copy of the Rules mentioned herein may be obtained from the AAA by visiting AAA's website at <http://www.adr.org>. The scope of this Agreement is intended to be as broad as possible under applicable law, and shall include all types of negligence, tort, contract, statutory and administrative actions. The parties further agree to submit to non-binding arbitration the issues of substantive and procedural arbitrability, including defenses to arbitration and all disputes regarding the enforceability, interpretation, breadth, scope and meaning of this Agreement. The parties reserve their rights to resolve disputes involving less than \$10,000.00 in an applicable small claims or district court in the county/parish and state in which the CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company is located that are within the scope of the small claims' or district court's jurisdiction. In the event non-binding arbitration does not totally resolve all claims, it is agreed that the sole and exclusive venue for any lawsuit filed against CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company shall be in the county/parish and state in which the CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company facility is located. It is further agreed that the substantive law of the State in which the CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company is located shall apply without regard to any conflict of law rules. Unless all parties agree otherwise, the non-binding arbitration decision or award may not be entered in any federal or state court having jurisdiction.

**By signing this document, whether in written or electronic format, I understand that I may be found by a court of law to have forever waived my and my spouse right to maintain any action in court or to be decided by a jury against CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company on the basis of any claim from which I have released CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and any released party herein and that I have assumed all risk of damage, loss, personal injury, or death to myself and/or my spouse and agreed to indemnify and hold harmless CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and all EQUIPMENT SUPPLIERS from and against any and all losses, liabilities, claims, obligations, costs, damages and/or expenses whatsoever paid, incurred and/or suffered by CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and all EQUIPMENT SUPPLIERS as a result of the participation in ACTIVITIES in or about the facility by myself and/or my spouse and/or claims asserted by myself and/or my spouse against CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company and all EQUIPMENT SUPPLIERS related to such participation in ACTIVITIES, whether or not such claims, losses, liabilities, claims, obligations, costs, damages, and/or expenses are caused by the negligence or fault of CIRCUSTRIX HOLDINGS, LLC, a New Jersey limited liability company or any EQUIPMENT SUPPLIERS.
